

Amending Budget 2012/1 Explanatory Note

1. Introduction

In compliance with Article 12 of Regulation (EC) № 1211/2009 of the European Parliament and of the Council of 25 November 2009 establishing the Body of European Regulators for Electronic Communications (BEREC) and the Office¹ (hereinafter referred to as “BEREC Regulation”), the budget of the BEREC Office has to be drawn up by its Management Committee in accordance with the procedure envisaged in the quoted Article. Where necessary, it has to be adjusted accordingly following the same procedure.

Articles 28 from Decision MC (11) 44 of the Management Committee on the financial regulation applicable to the BEREC Office in conformity with the framework Financial Regulation for the bodies referred to in Article 185 of Council Regulation (EC, Euratom) № 1605/2002 of 25 June 2002 on the Financial Regulation applicable to the general budget of the European Union (hereinafter referred to as “the BEREC Office Financial Regulation”) further specifies that any amendment to the budget, including the establishment plan, shall be the subject of an amending budget adopted by the same procedure as the initial budget, in accordance with the provisions of the BEREC Regulation and Article 27 of the BEREC Office Financial Regulation.

At this point of time it has become evident that the expected financial contributions from the European Free Trade Association (EFTA) Member States and those from the EU Member States or from their national regulatory authorities (NRAs) to be made on a voluntary basis in accordance with Article 5(2) of the BEREC Regulation will not be received within the current financial year.

The reduction of the revenue of the BEREC Office budget will require adjustment of its expenditure part.

The actual expenditure from the first semester of 2012 and the forecast for the second semester of the current financial year show that some of the staff and building, equipment and miscellaneous operating expenditure have been overestimated and their amount should be reduced;

However, in the current set-up phase there is a clear need to provide more training to the BEREC Office staff, which will require some increase of the financial resources for that activity envisaged in the 2012 budget.

The reduction in the revenues in the operational part of the Budget (Title 3) could be compensated by partially reducing the envisaged activities for collection and transmission of information and horizontal activities, specifically the number of external studies, which will not reach the levels expected. However, the support related workload and relevant expenditures to BEREC FD Art.7/7a and other Expert Working Groups (EWGs) have been higher in the first semester of 2012 than previously forecasted, which would require the increase of operational budget by 32,944 EUR, after the reduction on expenditure side of previously planned contributions from EFTA countries and NRAs of EU Member States. To ensure

proper financing of the BEREC activities envisaged in the BEREC Work programme for 2012, the increase in EWG support expenditures can be accomplished by transferring some money from the underspent budget in Titles 1 and 2..

In order to ensure better appraisal of the actual financial needs of the BEREC Office and with a view to maximise the efficiency of their management, the Administrative Manager has initiated consultation with the BEREC Chair and Vice-chairs, as well as with the Heads of the BEREC Office Units, the outcome of which has been taken into account in the First Draft Amending Budget for 2012, as presented below:

2. Budget

2.1. Revenues

The revenues and resources of the BEREC Office according to the 2012 Budget consist of:

- (a) a subsidy from the Community, entered under the appropriate headings of the general budget of the European Union (Commission Section), as decided by the budgetary authority and in accordance with point 47 of the Inter-institutional Agreement on budgetary discipline and sound financial management;
- (b) contribution from EFTA Member States and
- (c) voluntary contribution from the national regulatory authorities of the EU Member States in accordance with Article 5(2) of the BEREC Regulation.

At this point of time it has become evident that the expected financial contributions from the European Free Trade Association (EFTA) Member States will not be received due to delays in signing the relevant agreement for that at EU level.

The Board of Regulators has not envisaged either approving any contributions from the EU Member States or from their NRAs to be made on a voluntary basis in accordance with Article 5(2) of the BEREC Regulation within the current financial year.

For that reason the current amending budget suggest deleting the envisaged financial contributions from these two sources as presented on Revenue table below (see section Amending Budget 2012/1):

2.2. Expenditure

Title 1: Staff Expenditure

Chapter 11 "Staff Salaries and allowances": An amount of 714 000 EUR is released from salaries and allowances appropriations. This surplus is due to the recruitment of the new staff members during the third and fourth quarters of the current year and resignation of two staff members in 3rd quarter 2012, where replacement of the posts is underway. During the planning phase of the budget there was no clear overview of the dates of employment of new staff and the start dates of new employees were forecasted for an earlier period.

Chapter 13 "Mission Expenses": The appropriations of Chapter 13 are decreased by 218 000 EUR. According to actual data from the first semester, the number of missions for the first full year of activity was overestimated, considering even the increase in required support and missions for FD Art.7/7a EWGs. The budget is therefore adjusted accordingly.

Chapter 14 "Sociomedical services": The decrease of 6 000 EUR (relatively small in absolute terms, but 25% of the budget previously planned) is related largely to recruitment of new staff members in third and fourth quarters of 2012, as the reductions under Chapter 11.

Chapter 15 "Training": is increased by 24 500 EUR in the current amendment decision in order to address an accrued need for trainings in 2012, especially on administrative and financial matters among others. Experience is showing that the training needs in the start-up phase with new staff members are higher than in a mature organisation.

In addition to the current amendment and as compared to initial budget at the beginning of year 2012 (see column 3 in "Expenditures" table below), in May 2012 the Authorising Officer increased the Chapter 15 by 20 000 EUR and reduced respectively Chapter 11 "Staff Salaries and allowances" by 20 000 EUR. Management Committee was informed of this amendment during its plenary meeting on 25 May 2012. The May 2012 amendment is reflected in column 4 in "Expenditures" table below. See differences in columns 3 and 4 between budget lines 1100 and 1500.

Chapter 16 "External services": is increased by 23 000 EUR for the services provided by the Commission through SLAs, like payroll calculation and translations.

The total decrease in Title 1 amounts to 894 500 EUR.

Title 2: "Building, equipment and miscellaneous operating expenditure"

Chapters 20, 22, and 23: Estimates for infrastructure costs and other elements of administrative expenditure were based on available data for entities of similar size. The rental of the premises is currently provided free of charge during the first two years by the Latvian Government and the other administrative expenditure have been reassessed to the actual costs in Latvia and this results in a release of 398 524 EUR.

Chapter 21 "Information technology purchases": is increased by 40 000 EUR to address the current needs for hardware, software and IT related services. The increase above the forecast is related to better understanding of other agencies' expenditures on management software, particularly HR and document management tools.

Chapter 25 "Meeting expenses": The main part of expenses in this Chapter is the reimbursements to the members of the Board of Regulators and of the Management Committee. Also travel expenses of BEREC Chair and Vice-chairs have been taken into consideration. An increase of 21 000 EUR is needed. BEREC has set external relationships and stakeholder engagement as one of its strategic development goals. Focus on such strategic initiative has been enabled by improved operational capacities of BEREC and by increased efficiencies from BEREC/BEREC Office co-operation. The deeper engagement with stakeholders, however, also results in higher travel expenses, which has been taken into consideration with requested increase.

The total decrease in the appropriations of Title 2 amounts to 335 524 EUR.

Title 3: "Operational Expenditure"

The appropriations of Title 3 are reduced by 184 529 EUR and will cover all the operational needs currently foreseen, such as the reimbursements of travel costs associated with EWG meetings, organisation of workshops and support for translations, reports and studies on the key areas of BEREC activity and in support to accomplishing of the BEREC Work programme for 2012. The reduction amounts largely to the exclusions on revenue side of:

(a) contribution from EFTA Member States amounting to EUR 17 473 and

(c) voluntary contribution from the NRAs of the EU Member States amounting to EUR 200 000.

This total amount of EUR 217 473 is reduced by EUR 32 944, resulting from proposed increase in support expenditures to BEREC FD Art.7/7a and other Expert Working Groups (EWGs), which will be transferred from underspent money under Title 1 and 2 to this Title.

The total decrease in the appropriations of Title 3 amounts to 184 529 EUR.

According Decision MC (10) 44 on the financial regulation applicable to the BEREC Office in conformity with the framework Financial Regulation for the bodies referred to in Article 185 of Council Regulation (EC, Euratom) No 1605/2002 of 25 June 2002 on the Financial Regulation applicable to the general budget of the European Union any transfer of appropriations to and from Title 3 is subject to a prior written authorisation by the Commission, which will be requested following the approval of the current draft by the MC.

The initial reaction of DG Connect has been in support of the proposed transfer.

The proposed changes to the expenditure part of the Budget are presented in detail below (see section Amending Budget 2012/1).

3. Closing remarks

If adopted by the Management Committee the current decision is expected to enter into force on the day following its adoption.

In compliance with the BEREC Office Financial Regulation the full amending budget, including the comments, has to be published on the BEREC web site within four weeks from the date of its adoption.

A summary of the amending budget has to be published in the Official Journal of the European Union within three months from the date of its adoption.

All obligations related to the publication will be executed by the BEREC Office.
