

EU Emergency Services Workshop 2013

17-19 April 2013, Riga, Latvia

Context of the event:

Each year, EENA organises the EU Emergency Services Workshop that gathers European emergency services, public authorities and industry representatives. This 3-day conference aims at fostering sharing of best practice between the relevant stakeholders. High-level issues will be discussed during plenary sessions while operations and technical issues, including Next Generation 112, will be addressed during the parallel tracks. The 112 Awards Ceremony will be held in conjunction with the conference and will recognise and reward individuals and organisations particularly engaged in improving and promoting the European emergency number 112 as well as rewarding outstanding achievements by emergency service personnel and citizens. The EU Emergency Services Workshop will welcome about 400 participants, including about 200 emergency services and public authorities' representatives from all over Europe as well as other stakeholders such as telecom regulators and suppliers.
