Dear Sir/Madam,

- 1. The Office of the Body of European Regulators for Electronic Communications (hereinafter referred to as "the BEREC Office") is planning to award the public contract(s) referred to above. Please find enclosed the related tender specification listing all the documents that must be produced in order to submit a tender, and the draft contract. Please be informed that the tender is divided in two different lots as follows:
 - Lot 1 provision of professional event organisation services on the territory of the Republic of Latvia;
 - Lot 2 provision of professional event organisation services Europe-wide excluding the territory of the Republic of Latvia.
- 2. If you are interested in the contract(s), you should submit a tender in **one** original and **two** copies
 - a) either by post or by courier **not later than 19/04/2013**, in which case the evidence of the date of dispatch shall be constituted by the postmark or the date of the deposit slip, to the address indicated below:

- b) or delivered by hand **not later than 14.00 h on 19/04/2013** to the address indicated above. In this case, a receipt must be obtained as proof of submission, signed and dated by a staff member of the BEREC Office who took the delivery.
- 3. The tender (consisting of 1 original and 2 copies) should be enclosed in **two envelopes**, both of which should be sealed. If self-adhesive envelopes are used, they should be further sealed with adhesive tape, upon which the depositor's signature must appear.

The <u>outer envelope</u> should bear the following indication, in addition to the postal address mentioned above:

"INVITATION TO TENDER "PROVISION OF PROFESSIONAL EVENT ORGANISATION SERVICES IN EUROPE AND/OR IN THE REPUBLIC OF LATVIA FOR BEREC AND BEREC OFFICE EVENTS"

The inner envelope, addressed as indicated above, should contain <u>in addition</u> the indication: "NOT TO BE OPENED BY THE OPENING COMMITTEE BEFORE 13/05/2013". If self-adhesive envelopes are used, they must be sealed with adhesive tape and the sender must sign across this tape.

The inner envelope must also contain **two sealed envelopes for each Lot**, one containing the **technical section of the tender** and the other the **financial section of the tender**. Each of these envelopes must clearly indicate the content ("Technical Section" and "Financial Section") and the Lot for which the tender is submitted.

Tenderers must submit a **separate technical and financial tender for each Lot** for which they are tendering, which must be based on **Appendixes 1 and 2** to the technical specifications.

- 4. Tenders must be:
 - signed by a duly authorised representative of the tenderer;
 - perfectly legible so that there can be no doubt as to words and figures;
 - drawn up using the model reply forms in the tender specification.
- 5. The period of validity of the tender, during which tenderers may not modify the terms of their tenders in any respect, is **eleven months from the final date for submission**.
- 6. Submission of a tender implies acceptance of all the terms and conditions set out in this invitation to tender, in the tender specification and in the draft contract and, where appropriate, waiver of the tenderer's own general or specific terms and conditions. Submission of a tender is binding on the tenderer to whom the contract is awarded for the duration of the contract.
- 7. All costs incurred during the preparation and submission of tenders are to be borne by the tenderers and will not be reimbursed.
- 8. Contacts between the BEREC Office and tenderers are prohibited throughout the procedure save in exceptional circumstances and under the following conditions only:
 - Before the final date for submission of tenders:
 - At the request of the tenderer, the BEREC Office may provide additional information solely for the purpose of clarifying the nature of the contract.

Any requests for additional information must be made in writing only to the following functional mailbox: procurement@berec.europa.eu.

Requests for additional information received less than five working days before the final date for submission of tenders will not be processed.

- ➤ The BEREC Office may, on its own initiative, inform interested parties of any error, inaccuracy, omission or any other clerical error in the text of the call for tenders.
- Any additional information including that referred to above will be posted on the BEREC website, namely: www.berec.europa.eu. The website will be updated regularly and it is the tenderers' responsibility to check for updates and modifications during the tendering period.

- After the opening of tenders

➤ If clarification is required or if obvious clerical errors in the tender need to be corrected, the BEREC Office may contact the tenderer provided the terms of the tender are not modified as a result.

9. Opening of the tenders: 13/05/2013

The opening of received tenders will take place on **13/05/2013** at **10:00** at BEREC Office premises located at Zigfrīda Annas Meierovica bulvāris № 14, 2nd floor, Riga LV-1050, Latvia.

One authorised representative of each tenderer may attend the opening of the tenders. Tenderers who plan to attend the opening session have to inform BEREC Office by e-mail at *procurement@berec.europa.eu* by **08/05/2013** at the latest.

- 10. This invitation to tender is in no way binding on the BEREC Office. The BEREC Office's contractual obligation commences only upon signature of the contract with the successful tenderer.
- 11. Up to the point of signature, the BEREC Office may either abandon the procurement or cancel the award procedure, without the candidates or tenderers being entitled to claim any compensation. This decision must be substantiated and the candidates or tenderers notified.
- 12. Once the BEREC Office has opened the tender, the document shall become the property of the BEREC Office and it shall be treated confidentially.
- 13. You will be informed of the outcome of this procurement procedure by e-mail. It is your responsibility to provide a valid e-mail address together with your contact details in your tender and to check it regularly.
- 14. If processing your reply to the invitation to tender involves the recording and processing of personal data (such as your name, address and CV), such data will be processed pursuant to Regulation (EC) No 45/2001 on the protection of individuals with regard to the processing of personal data by the Community institutions and bodies and on the free movement of such data. Unless indicated otherwise, your replies to the questions and any personal data requested are required to evaluate your tender in accordance with the specifications of the invitation to tender and will be processed solely for that purpose by Mr Ando Rehemaa, Administrative Manager.
