TRAINING ON REGULATORY FRAMEWORK AND OTHER TOPICS RELATED TO BEREC ACTIVITIES

BEREC and its Office were established by Regulation (EC) No 1211/2009 of the European Parliament and of the Council of 25 November 2010. BEREC shall contribute to the development and better functioning of the internal market for electronic communications networks and services, by aiming to ensure a consistent application of the EU regulatory framework for electronic communications. The Office shall assist BEREC in this task, by providing professional and administrative support services. For more details on BEREC and BEREC Office please refer to the BEREC website.

BEREC Office would like to announce the launch of a negotiated procedure with at least three candidates in order to establish a fixed price direct service contract within a maximum threshold of 60 000 Eur. The purpose of the contract is to deliver to BEREC and the BEREC Office a series of trainings on regulatory framework and other topics related to BEREC activities. The training shall be provided during the second half of 2015; the venue of the residential training shall be Brussels, Belgium.

This publication is made pursuant to Article 124.1 (b) of the Rules of Application of the Financial Regulation that provides for an ex ante publication on the Institutions' websites of contracts with a value up to 60.000 EUR. The contract will have a duration of maximum one year and will not be renewable.


Only the economic operators having expressed their interest in time, will be invited by the contracting authority to participate in the above tendering procedure.

DESCRIPTION OF SERVICES REQUIRED



The purpose of this call for tenders is to deliver training courses to the BEREC members on the Regulatory Framework and other topics related to BEREC activities, so as to ensure that BEREC can fulfil its role.

The scope of the training shall be the following:

- Residential training divided into maximum four blocks according to the topics
- ii. On-line tutorials

More specifically, the following topics have to be covered in the training:

- Markets, competition and regulation
- EU policies and initiatives
- Access and interconnection
- Market analysis, Art 7 and Art 7a of the Framework Directive: Consolidating the internal market for electronic communications
- Spectrum policy
- International Roaming
- New Generation Networks including both fixed and wireless networks
- Social Regulation
- Regulatory accounting and cost models
- Net neutrality
- Merger control and state aid
- Competition policy and innovation in communications and media markets
- Internet

The frequency of the trainings is yet to be defined and might be adapted according to the needs of BEREC.

The training is expected to be attended by approximately 40-50 participants from the National Regulatory Authorities that are BEREC members as well as members of the BEREC Office.

In order to maximize the benefit of this training, webcasting for the BEREC members, may be used during some of the residential training modules as well as recording for future use.
