UGT, the largest trade union in the communications sector in Spain, insist on the statements we made in the previous phase of the consultation, which we reproduce below.

"UGT Comunications, the biggest union trade in Spain in the telecommunications sector, considers that the current regulatory model in the telecommunications sector focuses solely on competition, forgetting employment.

Because of this regulatory apathy, that resign to look of employment, the Communications Sector in Spain has suffered a massive loss of jobs: a third of employment has been lost in just 10 years. More than 28.000 jobs destroyed in that period.

No regulator should not remain it unmoved by this bleeding. It is their duty to address the employment aspect as a fundamental, essential and indispensable part of their regulatory policies. The competition and regulation not be turn away from the labour market.

Therefore, UGT considers that it is time to take into account the labour situation of the sector when it comes to regulate. UGT requests BEREC to include in this list the labour market implications of successive sectorial regulations. Because, according to our criteria:

- Regulation must pursue and foster economic growth based on permanent creation of quality employment
- Competition must become an instrument to guarantee employment
- Not only should you invest in networks, but you also need to invest in people
