

# Decision No BoR/2018/01 of the Board of Regulators on the appointment of the Remedies Expert Working Group Co-Chair

### THE BOARD OF REGULATORS.

HAVING REGARD TO Regulation No 1211/2009 of the European Parliament and of the Council of 25 November 2009 establishing the Body of European Regulators for Electronic Communications (BEREC) and the Office<sup>1</sup> (BEREC Regulation) and, in particular Article 4 (7) thereof;

HAVING REGARD TO the Rules of Procedure of the Board of Regulators<sup>2</sup> and, in particular Article 11(1) thereof;

HAVING REGARD TO the Internal Guidelines on the operation of BEREC Expert Working Groups<sup>3</sup> and, in particular point 1 thereof;

HAVING REGARD TO the Decision BoR/2016/04, with subsequent amendments, that creates the BEREC Expert Working Groups and appoints the Co-Chairs of the BEREC Expert Working Groups;

## Whereas,

- 1) The work of BEREC may be organised into Expert Working Groups;
- 2) The Board of Regulators should appoint the Co-Chairs of each Expert Working Group for the implementation of the BEREC Work Programme;
- 3) Each Expert Working Group shall be led by two Co-Chairs, from different NRAs, unless in exceptional and temporary circumstances;
- 4) The Board of Regulators has created nine Expert Working Groups and appointed all Co-Chairs with its decision of December 2016:

5) The Board of Regulators shall approve the decision that appoints the Remedies Expert Working Group Co-Chair replacing one of the Co-Chairs, who decided to terminate his mandate earlier, for the remaining term.

HAS DECIDED:

# **Article 1**

The following Expert Working Group Co-Chair is appointed for the Remedies Expert Working Group: Mr Jas Sheera.

## **Article 2**

The mandate of the above appointed Co-Chair will be up to 31 December 2018.

## **Article 3**

This decision shall enter into force on the day of its adoption by the Board of Regulators.

#### **Article 4**

All other provisions of Decision BoR/2016/04 of 8 December 2016 as subsequently amended remain unchanged.
