

Decision No MB/2019/09 of the Management Board of the Agency for Support for BEREC on the renewal of the term of office of the Director of the BEREC Office

THE MANAGEMENT BOARD OF THE BEREC OFFICE,

Having regard to Regulation (EU) No 2018/1971 of the European Parliament and of the Council of 11 December 2018 establishing the Body of European Regulators for Electronic Communications (BEREC) and the Agency for Support for BEREC (BEREC Office), amending Regulation (EU) 2015/2120 and repealing Regulation (EC) No 1211/2009, and in particular Article 32(5 and (6) and Article 49(3) thereof,

Having regard to Regulation (EEC, Euratom, ECSC) No 259/68 of the Council of 29 February 1968 laying down the Staff Regulations of Officials and the Conditions of Employment of Other Servants of the European Communities and instituting special measures temporarily applicable to officials of the Commission, and in particular point (a) of Article 2 of the Conditions of Employment of Other Servants,

Whereas:

- (1) The Management Committee appointed with Decision No MC/2014/4 Mr László Ignéczi as Administrative Manager for a period of three years as from 1 April 2014.
- (2) The Management Committee extended with Decision No MC/2016/14 the term of office of the Administrative Manager for three years as from 1 April 2017.
- (3) With effect from 20 December 2018, the Administrative Manager appointed on the basis of Regulation (EC) No 1211/2009¹ shall act as Director.
- (4) By the end of the current term of office of the Director, the Chairperson of the Management Board shall carry out an assessment that takes into account an evaluation of the Director's performance and the BEREC Office's tasks and challenges.
- (5) That assessment shall be submitted to the European Parliament and to the Council.

- (6) The Management Board, taking into account that assessment, may extend the Director's term of office provided that the cumulative term of office of the Director does not exceed 10 years.
- (7) The Chairperson of the Management Board completed the assessment and recommended to renew the term of office of the Director for four years as from 1 April 2020.
- (8) The Management Board agrees on the recommendation and intends to renew the term of office of the Director for a further term of four years as from 1 April 2020.
- (9) The assessment will submitted to the European Parliament and to the Council.

HAS ADOPTED THE FOLLOWING DECISION:

Article 1

The term of office of Mr László Ignéczi as Director of the BEREC Office is hereby renewed for a period of four years as from 1 April 2020.

Article 2

This Decision shall enter into force on the date of signature.
