

Decision MB/2024/15

of the Management Board of the Agency for Support for BEREC ('BEREC Office') on the adoption of the final Single Programming Document of the BEREC Office for the period 2025-2027

The Management Board,

Having regard to Regulation (EU) 2018/1971 of the European Parliament and of the Council of 11 December 2018 establishing the Body of European Regulators for Electronic Communications (BEREC) and the Agency for Support for BEREC ('BEREC Office'), amending Regulation (EU) 2015/2120 and repealing Regulation (EC) No 1211/2009¹, and in particular Articles 23 (1) and 24 (7) thereof;

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012²;

Having regard to the Communication from the Commission on the strengthening of the governance of Union Bodies under Article 70 of the Financial Regulation 2018/1046 and on the guidelines for the Single Programming Document and the Consolidated Annual Activity Report (document C(2020) 2297 final);

Having regard to the Decision MB/2019/13 of the Management Board of the BEREC Office on the financial regulation applicable to the BEREC Office in conformity with Delegated Regulation (EU) No 1271/2013 based on Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council of 25 October 2012 on the financial rules applicable to the general budget of the Union;

Having regard to the Decision No MB/2024/02 of the BEREC Office Management Board on the adoption of the draft Single Programming Document for the period 2025-2027³;

Having regard to Commission Opinion C(2024) 4834 of 9 July 2024 on the draft BEREC Office

Single Programming Document for the period 2025-2027; Having regard to the General Budget of the EU for 2025⁴.

Whereas:

- (1) In line with the requirements of Regulation (EC) No 1211/2009, the BEREC Office has drawn up a draft Single Programming Document for the period 2025-2027 containing a multi-annual and an annual work programme, an estimate of its revenue and expenditure, a resources programming document, information on its building policy, strategy for cooperation with third countries and/or international organisations, strategy for achieving efficiency gains and synergies, strategy for the organisational management and internal control systems including their anti-fraud strategy as last updated and an indication of measures to prevent recurrence of cases of conflict of interest, irregularities and fraud;
- (2) The draft Single Programming Document included all necessary actions to implement the mandate assigned to the BEREC Office related to the provision of professional and administrative services supporting BEREC in carrying out its regulatory tasks and the tasks, which would be implemented to ensure compliance with the financial, staff and other applicable regulations, applicable to the decentralized agencies;
- (3) Furthermore, the draft document has taken into account the requirements of Regulation (EU) 2018/1971 envisaging that the BEREC Office should be adequately staffed for the purpose of carrying out its duties and that the number of staff at the Agency should be determined in accordance with the principle of activity-based management;
- (4) The draft Single Programming Document for the period 2025-2027 was adopted by the Management Board in January 2024 by electronic voting procedure and submitted to the European Commission, to the Council and the European Parliament;
- (5) On 9 July 2024 the Commission approved its Opinion on the draft Single Programming Document of the BEREC Office for the period 2025-2027;
- (6) In its Opinion the Commission welcomes the BEREC Office's draft Single Programming Document and its overall quality and acknowledges that the programming document is in line with the objectives and tasks of the BEREC Office;
- (7) At the same time the Commission has made some recommendations, which have been examined by the BEREC Office Advisory Group and a proposal on how to reflect them in the final Single Programming Document has been passed by the Director to the Management Board;
- (8) The proposal from the Director takes into account the Commission Opinion, as well as other important developments, such as the adoption of the Final Budget of the EU

for 2025, the final BEREC Annual Work Programme 2025, a still high inflation rate in the host Member State, possible negative priorities to be activated in case of financial constraints, and the challenges to meet the requirements of the future cybersecurity legislation, the BEREC Office premises project and the uncertainties regarding the high costs of implementation and transition to a new financial software SUMMA.

- (9) On the basis of the considerations mentioned above, the Management Board should subsequently adopt the final Single Programming Document, which should be submitted to the European Parliament, the Council and the Commission.
- (10) The Single Programming Document shall become definitive after adoption of the general budget of the Union and, if necessary, shall be adjusted accordingly.
- (11) The delegation of powers to the BEREC Office Authorising Officer to make nonsubstantial amendments to the annual work programme of the BEREC Office as defined in Decision MB/2024/02 of the BEREC Office Management Board on the adoption of the draft Single Programming Document of the BEREC Office for the period 2025-2027, should not be amended;

Has adopted the following decision:

Article 1

- 1. The final Single Programming Document of the BEREC Office for 2025-2027 presented in document MB (24) 106 is hereby adopted.
- The current Single Programming Document of the BEREC Office 2025-2027 replaces the draft approved by Decision MB/2024/02 of the BEREC Office Management Board on the adoption of the draft Single Programming Document of the BEREC Office Activities for the period 2025-2027.

Article 2

- 1. This Decision shall enter into force on the day of its adoption.
- 2. The BEREC Office Director shall submit the BEREC Office Single Programming Document for 2025-2027, as presented in document MB (24) 106 to the European Commission, to the Council and the European Parliament in due time.
